Notice of Affidavit

Comes now Affiant _____ one of The People, (as seen in Article 1 Section 2 of the Florida Constitution) Sui Juris, in this court of record, do make the following claims,

Equality and Rights of Men

Whereas; Palm Beach County Board of Education members are not allowing the students, staff, teachers and volunteers to live freely by requiring Masks and Vaccines. Article I, Section 2 of the Florida Constitution states: All natural persons, female and male alike, are equal before the law and have inalienable rights, among which are the right to enjoy and defend life and liberty, to pursue happiness, to be rewarded for industry, and to acquire, possess and protect property. No person shall be deprived of any right because of race, religion, national origin, or physical disability. **One of the people has the right to choose** if he or she enjoys wearing a mask or not. That choice of liberty interest was not granted to the control of government officials, but to mothers and fathers. Nor did the people grant the authority in the constitution for government officials, who as Servants, to force vaccinations on the children or the people. If you do believe that you were granted this authority, please provide the Article and Section of the Constitution that shows that you have this authority.

People the Source of Power

Palm Beach County Board of Education members work for we the people (Virginia Constitution Article 1, Section 1)-That all power is vested in, and consequently derived from, THE People, that magistrates are their trustees and servants, and at all times amenable to them. Please take further notice that as Servants and Trustees of the People, you have **no** authority to force the People to wear a mask or become vaccinated, because of the benefit that you have been paid to provide the People. Take further notice, the funds being used to create a school program, come from the People.

Government Instituted for Common Benefit

Furthermore, Article 1, Section 3 Virginia states that government is, or ought to be, instituted for the common benefit, protection, and security of the people, nation, or community; of all the various modes and forms of government, that is best which is capable of producing the greatest degree of happiness and safety, and is most effectually secured against the danger of maladministration; and, whenever any government shall be found inadequate or contrary to these purposes, a majority of the community hath an indubitable, inalienable, and indefeasible right to reform, alter, or abolish it, in such manner as shall be judged most conducive to the public weal. Acting in maladministration is a reason for the People to bring forth removal.

US Constitution

Furthermore, US Constitution Article IV, Section 2, paragraph 1, The Citizens of each State shall be entitled to all Privileges and Immunities of Citizens in the several States.

Please take further notice that the forefathers of our nation realized that the government is here to serve and secure the rights of the People, nation or community and this text does not just deal with Virginia but “any” government that may be found inadequate. The people have a right to reform, alter, or abolish. Therefore, the people are giving you a chance to prevent the danger of Maladministration, but please take notice, that the people know that your will in doing what the people need for their safety is not the final conclusion;

Demand Removal of Mask Mandates

By the power of one of the people, and the power declared in the above constitutional provision, I, demand, require and order a complete removal of the mask mandate/requirements and vaccine mandate/requirements or forced treatments or interactions relating to the students, teachers, staff, and volunteers immediately. As seen above, all rights that were set forth in the above section are self-executing, and since you are being given notice that this is demanded. **Please respond to me at the given address with all information on the results; and Any attempt to trample the people's rights after this notice will be considered a trespass with full knowledge and intent; and Any man or woman who denies these claims are true must rebut them under penalty of perjury in the form of a sworn affidavit. Any man or woman who decides to suppress this affidavit agrees to pay \$30,000 and any disputes by any public officials or private actors who are bound by contract to the Florida Constitution agrees to have these matters heard before an Arbitrator of my choice and to be bound thereby. Any man or woman denying these claims are true must rebut these claims point by point within (3) days (72-hrs). Failure to respond means that by acquiescence you agree that all claims are true.**
