Registration and elections shall, and political party functions may, be regulated by law; however, the requirements for a candidate with no party affiliation or for a candidate of a minor party for placement of the candidate's name on the ballot shall be no greater than the requirements for a candidate of the party having the largest number of registered voters.

# Section 2, Article 6

#### § Electors

Only a citizen of the United States who is at least eighteen years of age and who is a permanent resident of the state, if registered as provided by law, shall be an elector of the county where registered. As amended on November 28, 2020.

# Section 1, Article 1

§ Political power. All political power is inherent in the people. The enunciation herein of certain rights shall not be construed to deny or impair others retained by the people.

Please take further notice that public officers are simply the trustees and servants of the people, and that the Constitutions are the trust indentures granting your powers and showing the rights of the beneficiaries [the people], therefore any power that you claim to have must be shown in the Constitution and any power that is not granted therein, does not belong to your office.

### Section 2, Article 1

§ Basic rights.—All natural persons, female and male alike, are equal before the law and have inalienable rights, among which are the right to enjoy and defend life and liberty, to pursue happiness, to be rewarded for industry, and to acquire, possess and protect property. ## Section 24, Article 1

## § Access to public records and meetings.

(a) Every person has the right to inspect or copy any public record made or received in connection with the official business of any public body, officer, or employee of the state, or persons acting on their behalf, except with respect to records exempted pursuant to this section or specifically made confidential by this Constitution. This section specifically includes the legislative, executive, and judicial branches of government and each agency or department created thereunder; counties, municipalities, and districts; and each constitutional officer, board, and commission, or entity created pursuant to law or this Constitution.

## Article I Sec. 3 in the Commonwealth of Virginia Constitution

#### § Government Instituted for Common Benefit

3. "That government is, or ought to be, instituted for the common benefit, protection, and security of the people, nation, or community; of all the various modes and forms of government, that is best which is capable of producing the greatest degree of happiness and safety, and is most effectually secured against the danger of maladministration; and, whenever any government shall be found inadequate or contrary to these purposes, a majority of the community hath an indubitable, inalienable, and indefeasible right to reform, alter, or abolish it, in such manner as shall be judged most conducive to the public weal." [Emphasis by Highlight Added]

Please take further notice that the forefathers of our nation realized that the government is here to serve and secure the rights of the People, nation or community and this text does not just deal with Virginia but "any" government that may be found inadequate.
