**Name: NOTICE OF AFFIDAVIT**

Comes now Affiant, \_\_\_\_\_, one of the people (as seen in Article 1, Section 5 of the Florida Constitution) Sui Juris, in this court of record, do make the

following claims:

Article I, Sec 5 of the Constitution of Florida of 1968, as adopted on the 5<sup>th</sup> day of November 1968, states that "The people shall have the right peaceably to assemble, to instruct their representatives, and to petition for redress of grievances"

In line with this overarching theme, the Florida Constitution secures the right for every elector qualified to vote in Florida, as a citizen of the United States, who has attained the lawful requirements, The necessary and proper powers to make sure that all that vote are qualified is the same power that would be secured and reserved in and by the people to check and make sure all processes were lawful.

**This is a notice and demand for the audit process to be started and completed.**

**Section 1, Article 6**

**§ Regulation of Elections**

All elections by the people shall be by direct and secret vote. General elections shall be determined by a plurality of votes cast. Registration and elections shall, and political party functions may, be regulated by law; however, the requirements for a candidate with no party affiliation or for a candidate of a minor party for placement of the candidate's name on the ballot shall be no greater than the requirements for a candidate of the party having the largest number of registered voters.

## **Section 2, Article 6**

### **§ Electors**

Only a citizen of the United States who is at least eighteen years of age and who is a permanent resident of the state, if registered as provided by law, shall be an elector of the county where registered. As amended on November 28, 2020.

## **Section 1, Article 1**

**§ Political power.** All political power is inherent in the people. The enunciation herein of certain rights shall not be construed to deny or impair others retained by the people.

Please take further notice that public officers are simply the trustees and servants of the people, and that the Constitutions are the trust indentures granting your powers and showing the rights of the beneficiaries [the people], therefore any power that you claim to have must be shown in the Constitution and any power that is not granted therein, does not belong to your office.

## **Section 2, Article 1**

**§ Basic rights.**—All natural persons, female and male alike, are equal before the law and have inalienable rights, among which are the right to enjoy and defend life and liberty, to pursue happiness, to be rewarded for industry, and to acquire, possess and protect property. No person shall be deprived of any right because of race, religion, national origin, or physical disability.

## **Section 5, Article 1**

**§ Right to assemble.**—The people shall have the right peaceably to assemble, to instruct their representatives, and to petition for redress of grievances.

## **Section 10 Article 1**

**§ Prohibited laws.** No bill of attainder, ex post facto law or law impairing the obligation of contracts shall be passed.

## **Section 24, Article 1**

### **§ Access to public records and meetings.**

(a) Every person has the right to inspect or copy any public record made or received in connection with the official business of any public body, officer, or employee of the state, or persons acting on their behalf, except with respect to records exempted pursuant to this section or specifically made confidential by this Constitution. This section specifically includes the legislative, executive, and judicial branches of government and each agency or department created thereunder; counties, municipalities, and districts; and each constitutional officer, board, and commission, or entity created pursuant to law or this Constitution.

**Article I Sec. 3 in the Commonwealth of Virginia Constitution****§ Government Instituted for Common Benefit**

3. "That government is, or ought to be, instituted for the common benefit, protection, and security of the people, nation, or community; of all the various modes and forms of government, that is best which is capable of producing the greatest degree of happiness and safety, and is most effectually secured against the danger of maladministration; and, whenever any government shall be found inadequate or contrary to these purposes, a majority of the community hath an indubitable, inalienable, and indefeasible right to reform, alter, or abolish it, in such manner as shall be judged most conducive to the public weal." [Emphasis by Highlight Added]

Please take further notice that the forefathers of our nation realized that the government is here to serve and secure the rights of the People, nation or community and this text does not just deal with Virginia but "any" government that may be found inadequate. The people have a right to reform, alter, or abolish. Therefore, the people are giving you a chance to prevent the danger of Maladministration, but please take notice, that the people know that your will in doing what the people need for their safety is not the final conclusion;

By the power of one of the people, and the power declared in the above constitutional provision. I, Affiant, demand, require and order a complete audit of the statewide election results of the November 3<sup>rd</sup>, 2020 General election, and all votes, machines and software. As seen above all rights that were set forth in the above section are self-executing, and since you are being given notice that this audit is demanded, please start the audit process and please respond to me at the given address with all information on the results; and Any attempt to trample the people's rights after this notice will be considered a trespass with full knowledge and intent; and Any man or woman who denies these claims are true must rebut them under penalty of perjury in the form of a sworn affidavit. Any man or woman who decides to suppress this affidavit agrees to pay \$30,000 and any disputes by any public officials or private actors who are bound by contract to the Florida Constitution agrees to have these matters heard before an Arbitrator of my choice and to be bound thereby. Any man or woman denying these claims are true must rebut these claims point by point within (3) days (72-hrs). Failure to respond means that by acquiescence you agree that all claims are true.

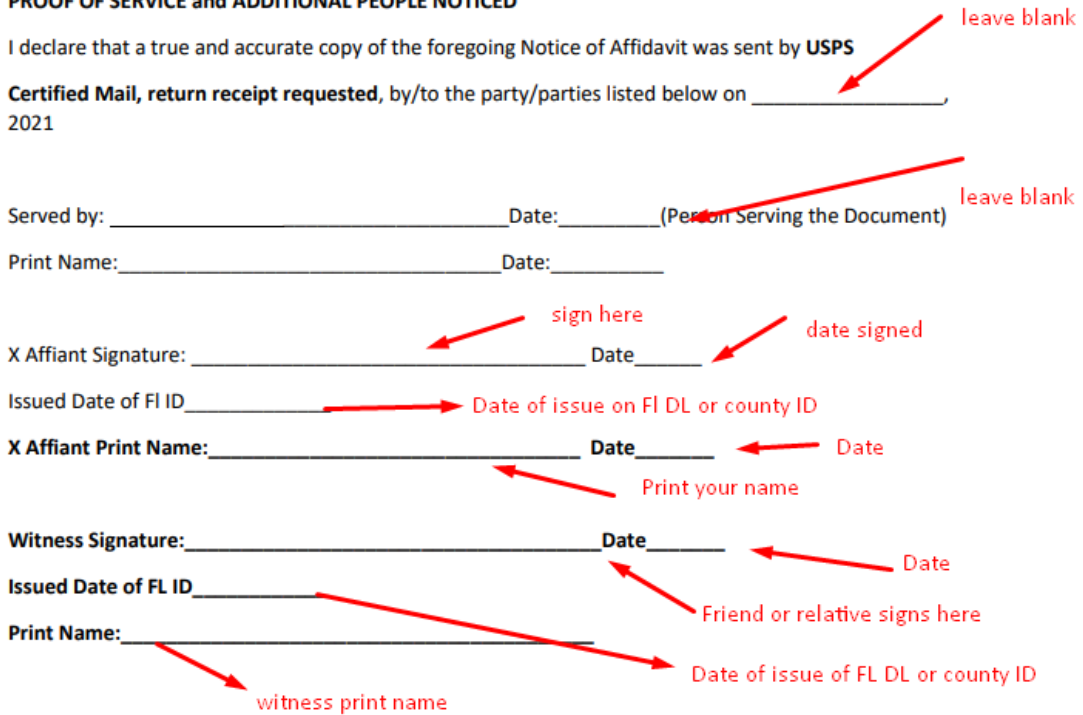
